September 1, 2021

The Heartbeat Act in Texas banned abortion after the detection of a heartbeat, which normally occurs after about six weeks of pregnancy. It relied solely on enforcement by private individuals through civil lawsuits, rather than having state officials enforce the law with criminal or civil penalties. The act authorized members of the public to sue anyone who performed or facilitated an illegal abortion.

June 24, 2022

The Supreme Court overturned Roe v. Wade, holding that there is no longer a federal constitutional right to an abortion. Going forward, abortion rights will be determined by states unless Congress acts. Already, nearly half of the states have or will pass laws that ban abortion while others have enacted strict measures regulating the procedure. It is up to the state to what extent if at all to allow abortions.

August 26, 2022

On August 26, the Human Life Protection Act, HB 1280, went into effect to completely protect unborn babies from the tragedy of abortion beginning at conception. The Human Life Protection Act is the last stake in the heart of the abortion industry in Texas. The Human Life Protection Act provides multiple avenues of protection against illegal abortions in Texas. The Guttmacher Institute, a leading advocate for legal abortion, reports that all 23 abortion facilities in Texas have ceased performing abortions. Violators can be sentenced to up to 99 years in prison, be fined \$100,000 or more, and lose their medical licenses. This bill does not allow prosecution for the treatment of a miscarriage or ectopic pregnancy, and

women cannot be charged for seeking an abortion.

From George Brooks, Board of Directors President: "Please note that abortions are illegal in Texas (with noted exceptions), but women are going to (prior) abortion clinics and doing video conferences so that abortion pills can be sent to them from out of state. Abortion pills are now available "on the streets" in the neighborhoods targeted for the deaths of their babies, some of which are counterfeits, and some of which are dangerous substances. The end game is to recognition that the unborn child in its tiniest and undeveloped condition is a person, small and they have a right to have their life protected
