49 Years of Lies

January 22, 2022 marked the 49th anniversary of the US Supreme Court ruling that a pregnant woman could choose abortion without excessive government restrictions.

Two US Supreme Court decisions changed American history forever: Doe v Bolton and Roe v Wade

In 1970, Cano, the Mary of Doe v Bolton, was a homeless mother of 3 children who had been taken away from her. Cano approached the local legal aid office seeking custody of her children and a divorce from her husband. What she received was something she never requested: the legal right to abort her child. Her legal-aid attorney, however, filed the case under false pretenses. Cano says that either the attorney forged her signature on the affidavit, or she slipped it in among other papers Cano was told to sign for her divorce. Cano never saw the affidavit that was filed with the Supreme Court, but she says unequivocally that what is stated is not true. Sandra Cano was never seeking an abortion. She was instructed to not say anything just be there at the Supreme Court hearing.

In 1969, Norma McCorvey, the Roe of Roe v Wade, was a self described hippie and was pregnant for the third time. She went seeking an illegal abortion and was referred to two lawyers, Sarah Weddington and Linda Coffee. She lied saying she had been gang-raped. They convinced her to take the case to court. It dragged out in the courts, McCorvey never got an abortion. She gave up the baby for adoption. When she found out that the case had gone all the way to the Supreme Court and resulted in legalizing abortion in all 50 states she was stunned. "It made me sad to know my name would always be connected to the death of children."

With these two decisions over 63.5 million lives have been denied the right to live. The potential lost is staggering. What could have been, is gone forever.



Texas Heartbeat Law



Texas Heartbeat Protection Act went into effect on Sept. 1. It made the biggest waves. It protects unborn babies from abortions once they have a detectable heartbeat. The law has a controversial enforcement mechanism that makes the law difficult to challenge in court. Instead of leaving enforcement to the state, the law tasks private citizens with suing abortionists and others who help women obtain an abortion after the baby has a detectable heartbeat. Some say it has cut abortions in half. Some women have responded with relief at seeing a heartbeat since it meant friends and family could no longer pressure them to abort.



In this sweet picture of a new mother and baby—laying on mother's chest close to her heart—is the result of courage. The mom was told on all sides to not have the baby. She struggled with father of baby leaving her, no place to stay, and anger from family members.

1. Client is very happy with positive result and she is about 28 weeks so she must have known. She is in need of baby items, maternity clothes, and is willing to come to class to accumulate points for more items. Father of the baby is unable to be present due to court order forbidding him to be near children!? She came in with sister-in-law. She is married to the client's brother. Family dynamics is hard to figure out. She is the sister-in-law but her baby isn't her brothers. The client asked if we knew who to contact regarding her leaving the country once the baby is born.
2. A 40 year old woman stomped into our office wanting a test. Her mother was with her. She just knew the test would be positive. It was not. She indicated she had symptoms, none of which were for pregnancy but more for anxiety and anger. She just found out that morning that her boyfriend she had waited for to get out of jail has found another girlfriend. He does not intend on coming back to her. Her mother explained that getting pregnant is not a way to keep a man. When asked if she had other children she said "No, thank God!" Her intake form showed she has been pregnant before 2 or 3 times!? She must have aborted but did not answer that question. She was told to come back if she needed to. She has not.
3. We had our first transgender client. She is 15 weeks pregnant. Although she presents herself as a male she is still female. She was violated by another transgender person. Very sad and confusing. She is very alone. Her co-workers think she is male. Doesn't want them to know. She is thinking adoption because of gestation. Pray she does. Louisiana is close to travel for abortion. Pray for her state of mind.
